- Be able to qualify as a BSHAA Fellow. Experienced members can become Fellows by following an approved learning path, contributing to the Society and to the profession. This entitles you to use the initials FSHAA after your name.

## Member categories

#### **Associate**

Any person who has an interest in audiology may become an Associate Member of BSHAA. Those who have completed an unapproved course of training to act as a hearing care assistant to a Fellow or Qualified Member of the Society may also enrol as an Associate of the Society. An Associate Member has voting rights.

#### Associate Hearing Care Assistant

A person who has successfully completed a BSHAA approved Hearing Care Assistant course may apply to become an Associate Hearing Care Assistant member. An Associate HCA has voting rights.

#### Associate Student Hearing Care Assistant

Whilst in training on an approved course the student may enrol as an Associate Student HCA. An Associate Student HCA will not be a full member of the Society and will not be entitled to vote.

#### Associate Student

A person studying for a BSc, MSc Degree or a Foundation Degree in Audiology or closely related subject may enrol as an Associate Student of the Society. An Associate Student, who wishes to apply for Qualified Membership status on graduation, may do so online via the Society's website or in writing to the Secretary. An Associate Student will not be a full member of the Society and will not be entitled to vote.

#### **Qualified Member**

A person who is on the HCPC Register as a Hearing Aid Dispenser, or has graduated with a BSc Degree, MSc Degree, or an approved Foundation Degree in Audiology or equivalent at a British University or passed the Irish Diploma of Audiology may enrol as a Qualified Member. A Qualified Member has voting rights. A Qualified Member can become a Fellow of BSHAA in accordance with the rules which are currently under review.

### Gaining Fellowship

The whole issue of gaining and retaining the much coveted Fellowship Status is under review. In his address to the 2015 Annual General Meeting, the Chief Executive David Welbourn said that Fellowship ought to be the pinnacle of the profession and in future, members wishing to gain or retain it would have to demonstrate a balanced portfolio of educational attainment, proven experience, contribution to the profession and contribution to the Society. He explained that the development needs of every member were different and consequently it was no longer appropriate to assume that everyone who sat through a given lecture would benefit in the same way.

Just as the HCPC expected its registrants to demonstrate that they had identified their development needs in any given year, undertaken learning and then demonstrated how this had benefited their practice, so, in future the Society would shift the emphasis to best practice for meeting professional development standards, particularly for Fellowship.
